A Protection from Abuse (P.F.A.) Order or an Anti-Stalking (P.F.S.) Order is an official court document that orders a person to stop the abuse or harassment. They are intended to protect victims from their abuser.

How do I get a Protection From Abuse (P.F.A.) Order?

- 1. The paperwork is available at the Sexual Assault & Domestic Violence Center. They will assist you in filling out the papers and give you helpful hints. Their address is provided on the back of this brochure.
- 2. You must be a family member, have lived with the person or dating the person you want a P.F.A. order for.
- 3. The Judge will give you a temporary order and set a date for a hearing. The temporary order must be carried at all times.
- 4. You must go to the hearing and tell the Judge why you need the order.
- 5. The Judge will decide if a permanent P.F.A. is needed.
- 6. The P.F.A. order is good for twelve (12) months and can be extended for twelve (12) more.
- 7. You can only get two (2) P.F.A.s in a twelve month time period.

How do I get a Protection From Stalking (P.F.S.) Order?

- 1. Notify Law Enforcement of the harassment.
- 2. The paperwork is available at the Sexual Assault & Domestic Violence Center. They will assist you in filling out the papers and give you helpful hints. Their address is provided on the back of this brochure.
- 3. You will need to provide the name of the offending person and describe what they are doing.
- 4. The Judge may give you a temporary order. The temporary order must be carried at all times.
- 5. The Judge will set a hearing date within 20 days. You must go to the hearing.
- 6. At the hearing the Judge will decide if a P.F.S. is needed and sign a final order.
- 7. The P.F.S. order is good for twelve (12) months and can be extended twelve (12) more.
- 8. Your name and address will not be disclosed.

QUESTIONS

- Q: What does the Court consider to be abuse?
- A: Abuse is bodily injury, threat of bodily injury, or sexual touching.
- Q: What does the Court consider to be stalking?
- A: Stalking is intentional harassment that places a person in reasonable fear for their safety.
- Q: How much does a P.F.A./P.F.S. cost?
- A: It is free to request one.
- Q: How old do you have to be to get a P.F.A./P.F.S.?
- A: 18 years old. If under 18, a parent or adult living with the child can get one one for the child.
- Q: Do I need a lawyer to get a P.F.A./P.F.S.?
- A: It may be helpful to have a lawyer but you do not need one.
- Q: Does a P.F.A./P.F.S. have to last twelve months?
- A: No, but you have to ask the Judge to change or drop the order.
- Q: What happens if the order is not followed?
- A: If the other person does not follow the order contact the Police. DO NOTTRY TO ENFORCE THE ORDER YOURSELF.
