ADDITIONAL CONDITIONS OF PROBATION FOR SEX OFFENDERS

As a registered Sex Offender, the defendant shall:

1. Have employment approved by RCCC. Intensive Supervision Officer (ISO) will notify employer that probationer is a registered Sex Offender.
2. Actively participate in treatment with a therapist approved by RCCC. Active participation shall be defined by the therapist and the ISO. Defendant shall pay for the treatment.
3. Participate in periodic polygraph tests or Computer Voice Stress Analysis tests as requested. Defendant shall pay for the tests.
4. Not have any unauthorized contact with persons under the age of 18 while in Sex Offender treatment.
5. Not frequent places where youth congregate, such as schoolyards, parks, playgrounds, and arcades. If there is a question about a specific location, the ISO must be consulted in advance.
6. Have all travel destinations pre-approved by ISO. If allowed to travel, defendant shall maintain a driving log (including any stops made). **Priority travel** includes but is not limited to court appointments, personal medical appointments, immediate family emergencies, verifiable work-related duties, etc.

Any **non-priority travel** outside of the county of residence will not be considered unless the following has occurred:

- a. All current fees are paid up to date, including court fees and RCCC fees.
 - b. In good standing with all treatment providers, including attendance, participation, and payments.
 - c. All agreed-upon tasks met as outlined in supervision plan.
 - d. No violations of any Conditions of Probation within the last 60 days.
7. Not drive a motor vehicle alone without prior permission of ISO.
 8. Not possess any pornographic, sexually oriented, or sexually stimulating visual, auditory, telephonic, or electronic media and computer programs or services that are relevant to the deviant behavior problem. This will be defined by the therapist and ISO.

Page two – Additional Conditions of Probation for Sex Offenders

9. Reside at a place approved by the ISO, which includes approval of residents living at the requested address.

10. Abide by any curfew imposed by the supervising officer and comply with electronic monitoring, if so ordered.

11. Not have contact, directly or through third parties, with the victim(s).

12. Abstain from any intoxicating substances unless prescribed by a licensed medical practitioner.

13. Not have a Post Office box number or private mail service box number without the approval of the ISO.

14. Not use fictitious names.

15. Complete a weekly schedule of planned activities, which is to be approved by the ISO. The schedule is to be specific and any deviations from the planned schedule must be reported to and/or approved by the ISO.

16. If the use of a computer is authorized by the Court, agree to abide by the separate Computer Use Agreement for Sex Offenders. This includes the installation of computer monitoring software by Reno County Community Corrections and payment of the associated costs of such software and/or installation.
